### 1. INTRODUCTION

1.1 This Technical Note sets out results of the construction monitoring being carried out at the above site between Monday 20<sup>th</sup> April & Saturday 2<sup>nd</sup> April 2026. The monitoring is being carried out in general agreement with the methodology in the current Section 61 Consent between the London Borough of Islington and London Square.

### 2. SITE ACTIVITIES

2.1 The following activities have been carried during the period covered by this report, in addition to the usual use of the Haul Road with site vehicles, and mobile plant used around the site:

- Fixing works and brickwork at Blocks C & D & E2.
- Block E window installations.
- Marketing suite construction within the proximity of Block C1.
- Brickwork and internal fitout across Blocks D2 & D3.
- Scaffolding & waterproofing works at Blocks E, which finished during the week commencing 4<sup>th</sup> May.
- Installation of services and pavements on Pankhurst Road, which finished during the week commencing 27<sup>th</sup> April.

### **3. MONITORING DATA**

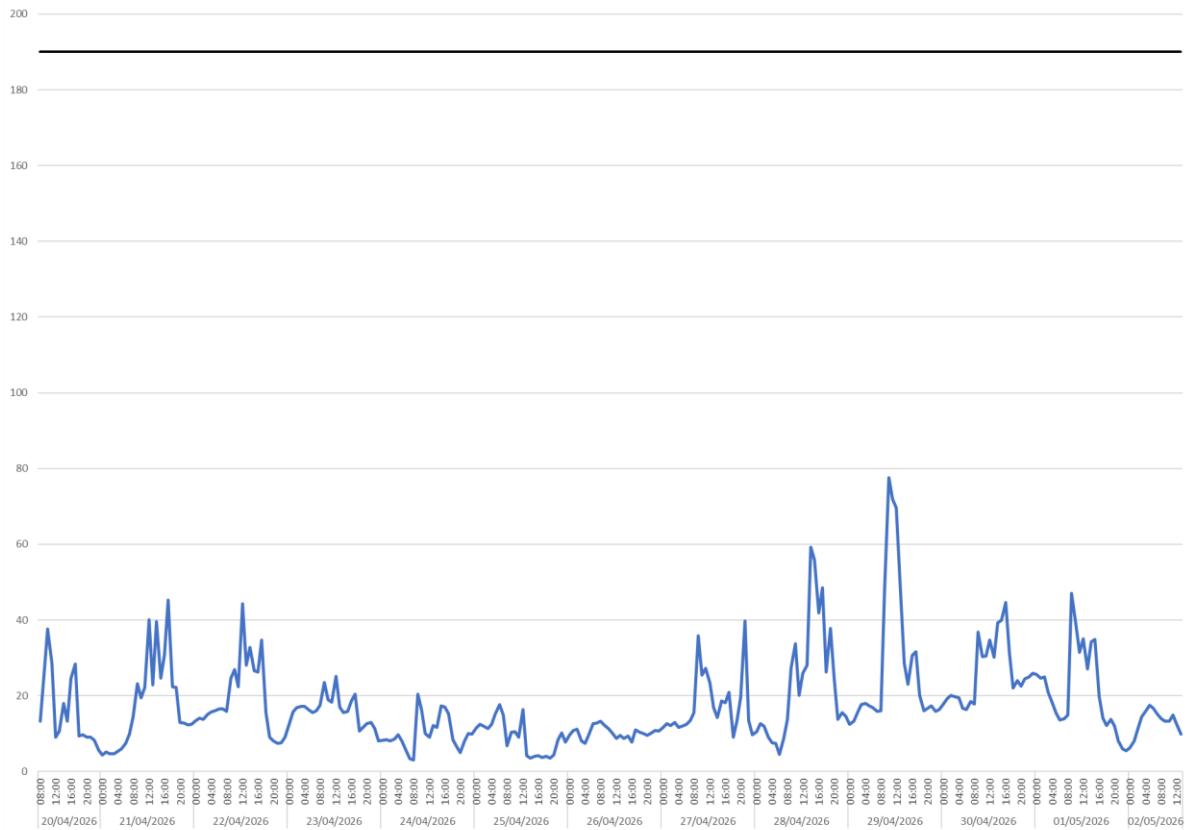
- 3.1 This section sets out a summary of the monitoring data that has been recorded onsite and provides a discussion of any exceedances and best practicable means incorporated by the site team if exceedances were believed to be construction related.

#### **Dust Monitoring Results**

##### Location 1 (meter ref. TNO4728)

- 3.2 There was 0% data coverage during the monitoring period, as the monitor was removed from site on Wednesday 17<sup>th</sup> December 2025 for its laboratory calibration (required every two years). This was returned to site on Friday 13<sup>th</sup> February. However, this monitor has remained offline due to water damage to the webserver, which occurred whilst the dust monitor was out for calibration. The webserver was sent to the manufacturer for repair and has since been sent back to Cass Allen. A site visit will be arranged to reinstall this, to allow the monitoring to continue as normal.
- 3.3 The data for Locations 2 & 3 is shown overleaf.

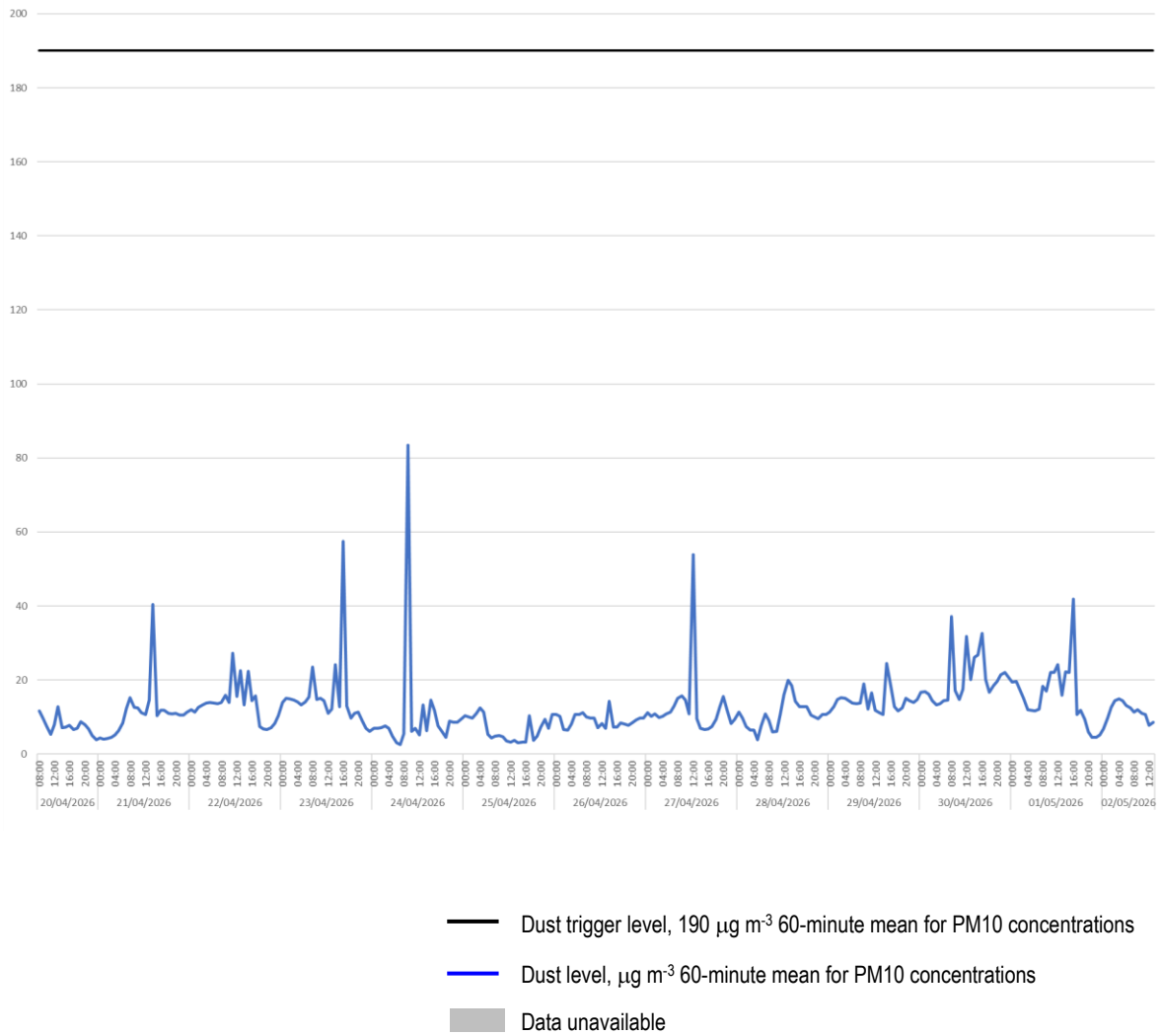

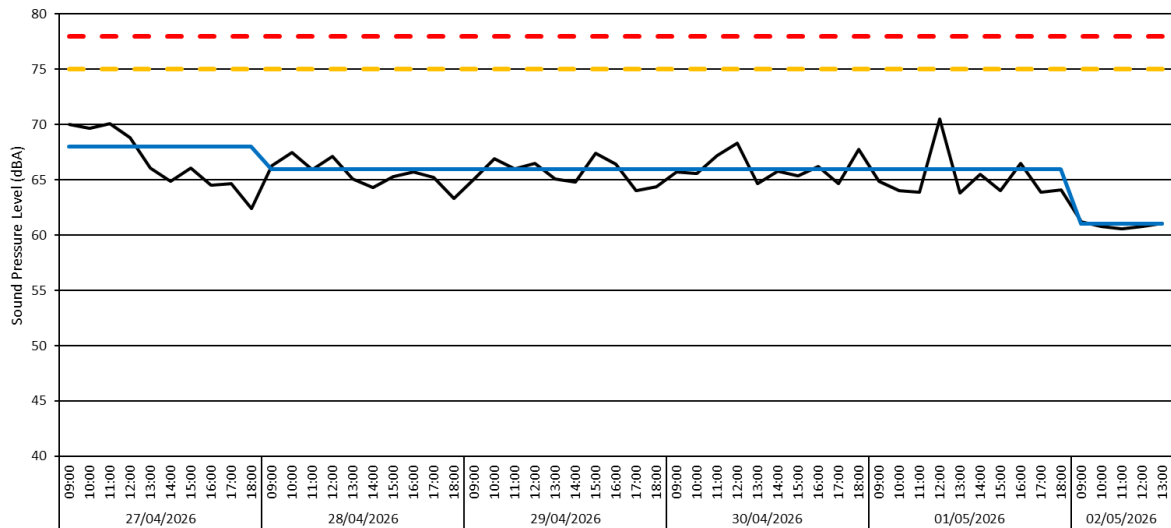
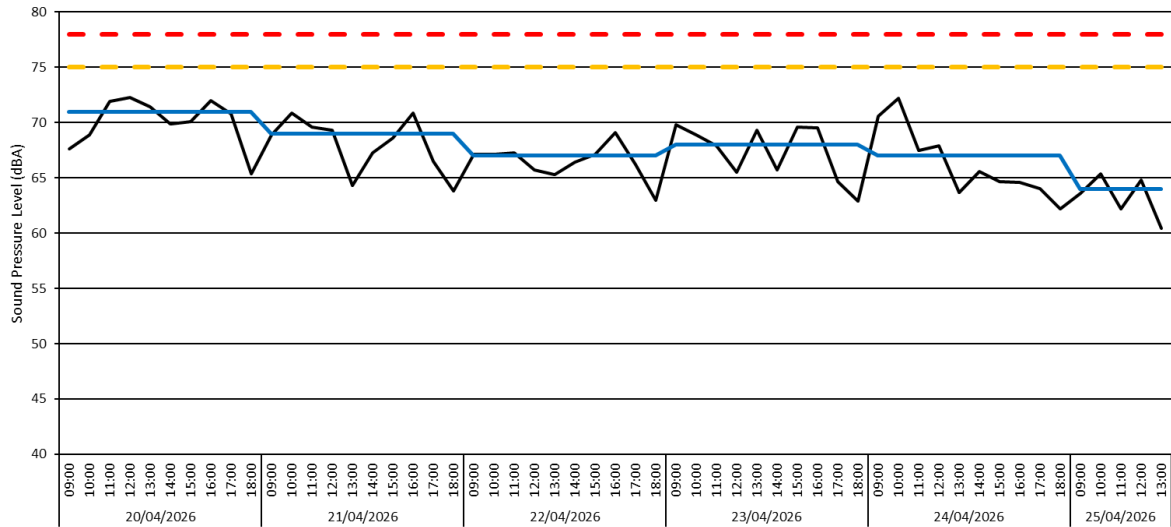

Location 1 (meter ref. SMENK-9E5DF) – Time History Data



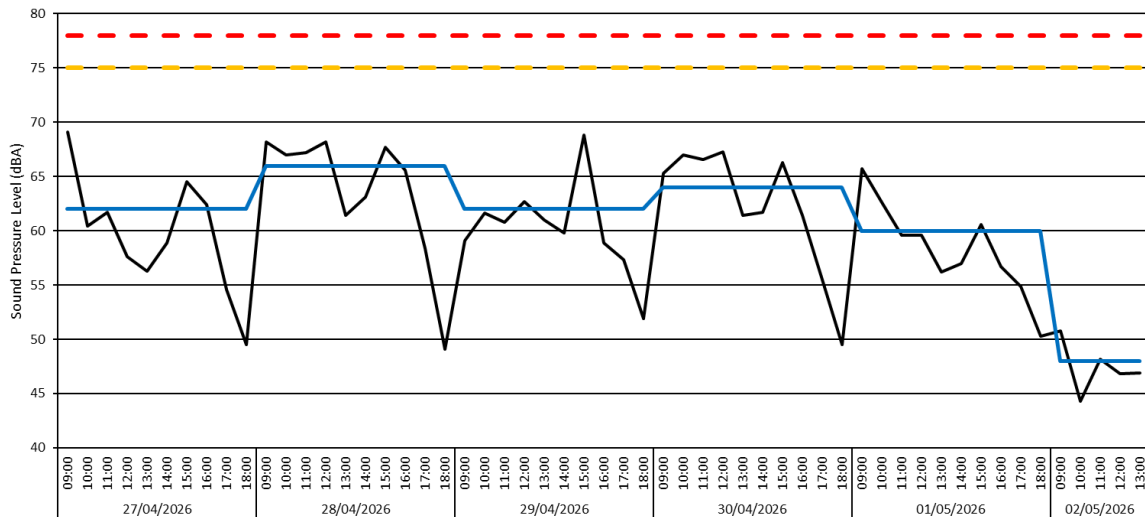
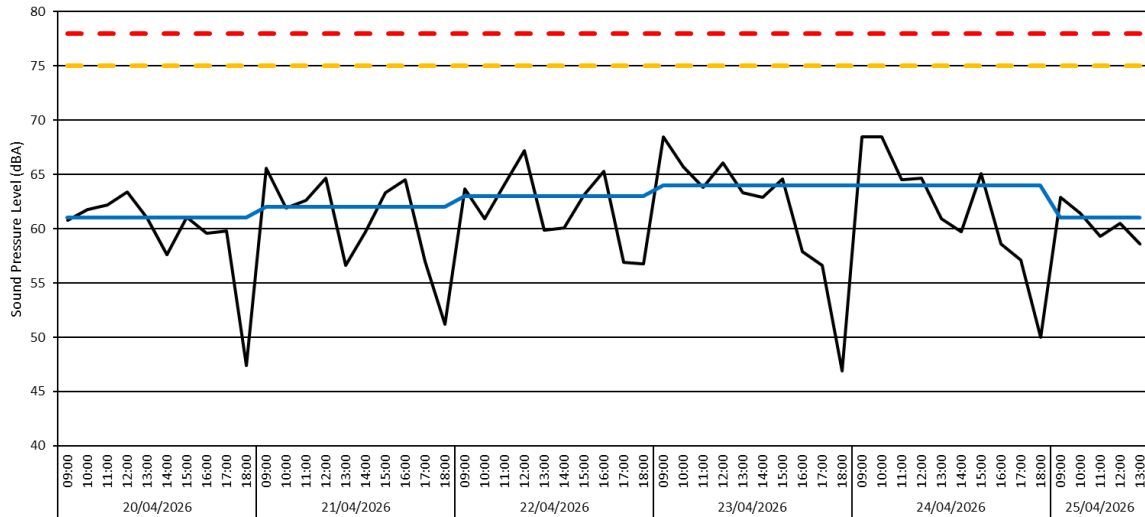

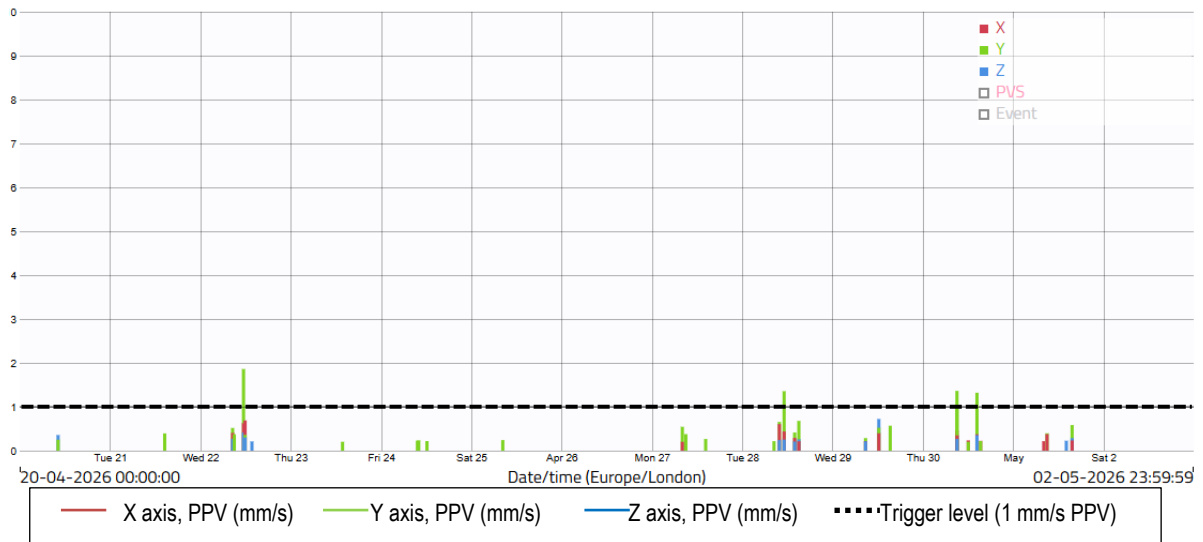

3.10 There was 100% data coverage at Location 2 during construction hours for the monitoring period covered by this report. There were five exceedances of the project vibration trigger level of 1.0 mm/s PPV. The highest recorded level occurred on Wednesday 22<sup>nd</sup> April at 11:29, with a recorded level of 1.86 mm/s PPV. Based on discussions with site management, the exceedances are understood to have been caused by the brickworks at Block E2.

Location 3 (meter ref. RIYORU)

3.11 There was 0% data coverage at Location 3 during construction hours for the monitoring period covered by this report due to a drained battery. This has been raised with the site team and data collection is expected to return to normal. This will continue to be reviewed.

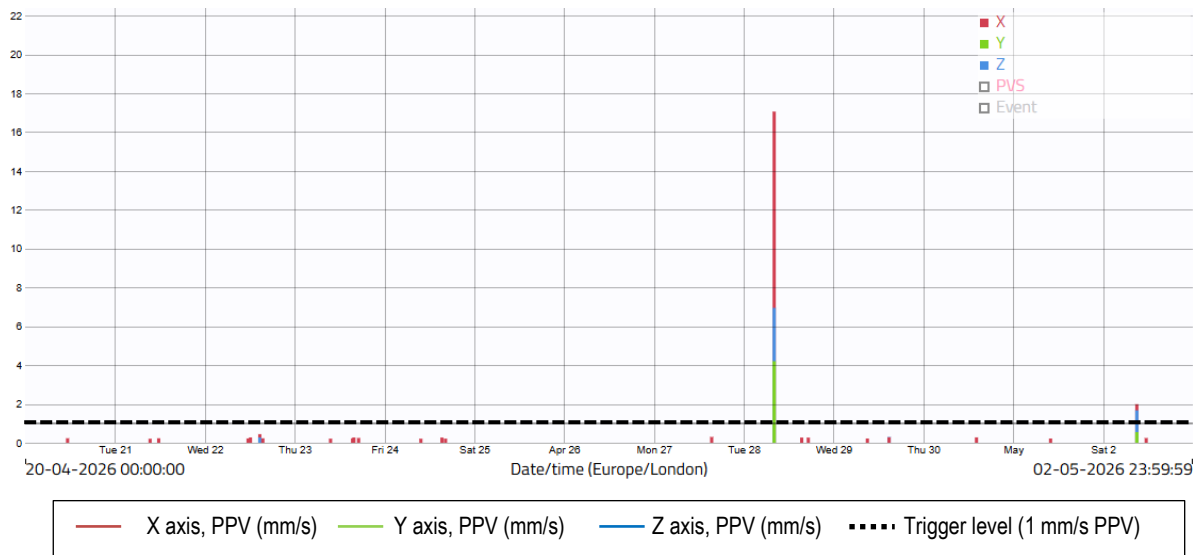

3.12 There was 100% data coverage at Location 4 during construction hours for the monitoring period covered by this report. There were two exceedances of the 1 mm/s PPV vibration trigger level at this location during the monitoring period covered by this report. The highest recorded level occurred on Tuesday 28<sup>th</sup> April at 08:08, with a recorded level of 17.06 mm/s PPV. As this was a standalone high reading, with no other exceedances occurring on the same day, this was likely caused by the meter being knocked, as opposed to continuous construction activity.
